Enclosed please find a Trader Application and a flyer for the 2011 Winter Benefit Pow Wow to be held February 5, 2011 at the Will County Fairgrounds in Peotone, IL. If you are interested, please complete and return the Trader Application and appropriate Trader Fees to me at the address listed below.

This year we will have 21 trader spaces available. I will assign trader spaces as I receive the paid applications and will send a confirmation letter showing the assigned space. You will need to furnish your own tables, chairs, lights, extension cords. **There is no walkway between spaces unless you provide one from part of your space.**

The cost per Trader space is **\$35** until January 15th and **\$45** after January 15th. **Each space is approximately 10 feet across the front and 10 feet deep** with electricity close by.

If you will be serving food, or selling pre-packaged food products of any type please remember that you must get a permit from the Will County Department of Public Health. You must get this before the Pow Wow. There will be a County Health Inspector on the Pow Wow grounds. Trader setup starts at 7am on Saturday February 5th at the Fairgrounds until 11am. All booths must be set and ready to go by 11am. (Gate opens at 11 am)

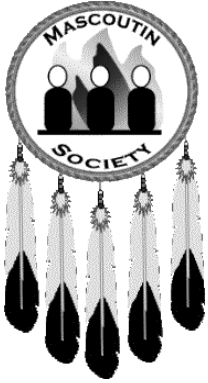
